Proposed Amendment to Charter and Bylaws of The American Kennel Club

The Board of Directors has approved the following amendment to ARTICLE VII, SECTION 1, of the Charter and Bylaws of The American Kennel Club, to be voted on at the June 13, 2011, Delegates Meeting.

ARTICLE VII

SECTION 1. No person shall be eligible to

serve more than two consecutive terms on the Board. A term of service shall be four years. A Board member who has served more than half a term on the Board is considered to have served a full term. If a Director has served two consecutive terms he or she becomes ineligible for re-election to the Board of Directors for the length of one full term of four years.
