SCRATCH POLICY AFTER CLOSING DATE

Entries will be refunded in full to dogs that have an injury or illness that prevents them from running in the stake. An appropriate veterinary certificate may be required.

QUALIFICATIONS

Open to all AKC registered Pointing Breeds that have met at least one of the following qualifications: Earned an AKC Field Championship or Amateur Field Championship title, or during the period of <u>January 1</u>, <u>2019 to December 31, 2020</u>, placed 1st, 2nd or 3rd in any AKC Gun Dog stake (Open or Amateur) with at least 13, 18 or 25 starters, respectively.

FORMAT

The 2021 event will include one non-retrieving Championship stake. Each brace will be one hour in length over multiple courses. We plan to run six braces per day - three in the morning and three in the afternoon on a continuous course. The trial will run on native quail and any other legally hunted upland gamebirds that may be on the grounds - birds will be released during the trial. The dogs will be judged in accordance with AKC Pointing Breed Gun Dog standards. At their discretion, judges may post "top dogs" on a daily basis. Being posted as a "top dog" does not guarantee a placement. Horseback handling is permitted; anyone needing to rent a horse please contact Tom Maneely at TAM2@akc.org. AKC approved tracking collars used in accordance with AKC rules will be permitted. The host club will not provide tracking collars.

Being posted as a "top dog" does not guarantee a placement. The event will be non-retrieving. <u>Horseback handling is not permitted</u>. AKC approved tracking collars used in accordance with AKC rules will be permitted.

I (we) acknowledge that the Rules Applying to Registration and Dog Shows and, if this entry is for an obedience trial, the "Obedience Regulations" and, if this entry is for a field trial, the "Registration and Field Trial Rules and Standard Procedure for Pointing Breeds" and, if this entry is for a hunting test, the "Regulations for AKC Hunting Tests for Pointing Breeds," have been made available to me (us), and that I am (we are) familiar with their contents. I (we) agree that the club holding this show or obedience trial or field trial has the right to refuse this entry for cause which the club shall deem to be sufficient. The minimum standard of competition to qualify for a National Championship event as given in Chapter 14 of the Rules must be met.

At the 2021 Gun Dog Championship, no breeds qualify under this provision.

NOTE^{**} We recommend you do not travel on Dave Ward Drive because they have installed traffic circles which would be extremely difficult to negotiate with a horse trailer. Your GPS may try to direct you toward Dave Ward Drive.

NOTE TO TRIAL PARTICIPANTS AND VISITORS

Please use designated areas for camping and parking. Exhibitors are expected to clean up after themselves and their animals. This includes filling in any holes their dogs/horses create, spreading/removing horse manure, removing leftover hay, picking up/removing dog waste and generally cleaning up their camp area before leaving. Those who fail to do so may be charged a \$100 clean-up fee and denied entry to future events. All participants, guests and entries are accepted on the condition that the AKC Pointing Breed Championship, its officers, members, officials and volunteers, Camp Robinson and its members are released from liability for loss, damage or injury sustained by people, dogs or horses in connection with or during the trial.

GROUND RULES AT CAMP ROBINSON:

1. All horses must be accompanied by proof of a negative Coggins test that is current within the past 12 months.

2. No staking out of dogs unless all kennels are full.

3. No staking of horses or dogs in the inner camping area due to electric and water lines. Use area outside of the inner camping area.

4. No stock trailers allowed in the inner camping area.

5. Please fill holes and pick up your trash.

CAMPING

Overnight camping is allowed on the dog trial grounds. There are limited sites with electrical hook-ups. No dogs or horses may be staked out in camping area.

GENERAL INFO

- The roading of dogs behind the gallery will be permitted. The committee will limit the number of people roading to two at any one time.
- Local hay will be available for sale on the grounds.
- Breakfast, lunch, and dinner will be available for purchase each day.
- Club House: At the time of this premium's publishing, only 25 people are allowed in the clubhouse at one time due to Covid-19 restrictions. The outside covered patio has picnic tables and has no restrictions on the number of people. Restrooms are available inside the clubhouse during the day, and outdoor bathrooms and showers will be open during the trial.
