ELIGIBILITY TO ENTER

The qualifying period for the Fast CAT Invitational is Jan. 1 to Dec. 31 of the previous year.

The top 10 dogs in each breed, including ties, published in the official online invite list found on the AKC Fast CAT Invitational webpage are eligible to participate and are invited to attend. Anyone owning or handling a qualified dog published in the official invite list may use the online or paper entry form to enter anytime entries open. **Remember this is an invitational event and all dogs invited already earned their spot to attend and will run, so long as they enter before the deadline.

Qualified dogs are based on the [Fast Cat Top 20 Fastest Dogs By Breeds](#) (this includes breeds with less than 10 top dogs or breeds with more than 10 top dogs due to ties) and published in the official online invite list. The Top 20 Fastest Dogs By Breed ranking reflects the average of each dog's three fastest runs. Breeds not appearing in the rankings do not have any dogs that completed 3 Fast CAT runs in 2025. (*Please also see "*Breed Splits*" in the next section for additional dogs to be invited.) Depending on the number of declines received, AKC reserves the right to offer and announce a second round of invitations beyond the 10th place to ensure breeds are represented. AKC also reserves the right to change daily event scheduling, cancel or reschedule any events during Fast CAT Invitational week should circumstances arise.

Should a change in registration status take place which precludes a dog from remaining on the published invite list, the next ranked dog will be invited provided entries have not closed. Examples of why a change in registration status can occur are - deemed impure, involved in a case, disqualified, etc.

The AKC reserves the right to extend an invitation to attend when in the opinion of the Event Committee there exists extenuating and unusual circumstances which prevented attendance at the previous year's Invitational event and upon doing so any times recorded at the current invitational event may not be counted toward the current year's rankings.

The Event Committee of an AKC hosted major event shall have the authority to decide upon any matters arising which is not already specifically addressed in the Fast CAT/CAT Regulations. This includes matters related to the event that may occur before, during or after the event. Should a situation arise where the application of a Regulation is open for interpretation, the Event Committee shall decide how it will be handled.

Invitations are emailed to the primary owner's email address as recorded on the dog's registration. It is the responsibility of the primary owner to be sure they have the correct email address on file with AKC in advance. To check or update an email address, please send your request to: akcfastcatinvitational@akc.org or call 919-816-3340. It is the responsibility of the primary owner to contact AKC if they did not receive their invitation and would like to have it resent or sent to a different email address prior to the entry deadline. Undelivered, unreceived or unread invitations do not prevent an entry from being submitted for a qualified dog by the deadline. As long as a dog is published in the online invite list and entries have opened, the dog can be entered. If you did not receive your invite please, contact us and we will resend it.

BREED SPLITS

The following breeds have been split by height. (Height classes: under 12", 12" up to less than 18", 18" or over). Top 10 dogs in each height category of these breeds are invited to attend. – **All American, American Eskimo, Beagle, Dachshund, Manchester Terrier, Peruvian Inca Orchid, Poodle, Portuguese Podengo, Rat Terrier, Xoloitzcuintli.**

Entries Close Friday, August 14, 2026 @ 9:00PM (EST)

The **entry fee of \$175** includes all days of the Invitational. Qualified runs completed by dogs during the preliminary rounds and final will count towards titles

Entry fees shall be fixed by the host club and shall be forfeited by the owner or agent in such cases where dogs are scratched from the field except as follows:

1. Dogs determined to be lame or unfit to participate by the Inspection Committee, owner or agent at the time of roll call or upon previous notification by the owner or agent. These dogs shall be barred from participating and their entry fees shall be refunded in full.
2. Bitches in season may not participate, or bitches which come in season after the close of entries, shall be barred from participating in the test and their entry fees shall be refunded in full. Notification to the Secretary of bitches in season, must be made before or during the roll call. A note from a veterinarian is not required. Bitches known to be in season shall not be brought onto the test grounds.

Entries withdrawn prior to closing will be refunded. The Event Committee has the responsibility to determine refunds in unusual situations.

The owner or handler entering a dog in a CAT or Fast CAT event does so at their own risk. Owners and handlers of dogs entered agree to assume responsibility for any damage to facilities or persons, or dogs caused by him or her or by his or her dog(s). They also agree to abide by the rules, regulations and policies of The American Kennel Club and the CAT and Fast CAT Regulations.

No entries will be accepted by phone, fax or hand delivery. UPS and FedEx mail may be sent to the Event Secretary's address above. Express mailed entries must include the signature waiver allowing them to be left at the Secretary's address without a signature being required. It is the exhibitor's sole responsibility to assure their entry is delivered by the closing date and time. Illegible entries will not be processed and will be returned to the exhibitor. Returned checks do not constitute a valid entry. A twenty-five (\$25) dollar collection fee will be added to the amount of each returned check. Exhibitors may only submit paper entries using the Official AKC Fast CAT Invitational Entry Form provided with their invitation, or in this premium list or the downloadable PDF file published on the event website. Please do not submit pre-filled, generic entry forms; your entry will not be accepted. *Returned or postdated checks or declined credit cards do not constitute a valid entry.*

ADDITIONAL INFO NEEDED AT TIME OF ENTRY

T-Shirt Size - All Fast CAT Invitational exhibitors will receive a free official t-shirt offered in unisex adult sizes. One t-shirt per dog entered. A t-shirt size must be submitted with entry. The size ordered is the size that will be waiting when exhibitors arrive at check-in. Additional t-shirts, will be available for purchase on the grounds starting at \$35/each.

Titling Rosettes – All Fast CAT Invitational exhibitors should tell us at the time of entry if their dog is likely to earn a Fast CAT title while at the Invitational so they can receive their complimentary title rosette. The number of titling rosettes on hand will be based on the information provided on the entry form. All runs – both preliminary and final will count towards titles. Please note the number of titling ribbons ordered is based on this count so please try to be as accurate as possible. A small reserve of extras will be ordered in case of inaccurate counts provided on entries. Should there be any shortage of title ribbons, one will be mailed following the event.

Fast CAT Titling Structure - Titles are earned by accumulating points. The following titles will be awarded: BCAT = 150 points DCAT = 500 points FCAT = 1,000 points FCAT# = for every additional 500 points earned after earning an FCAT title a number will follow. (e.g. FCAT2) These suffix titles will appear on a dog's pedigree, with a higher-level title superseding a lower-level title. Titles must be earned in order.

Fast CAT Invitational - CHECK-IN

Exhibitors are to check-in at the secretary table located under the big tent on the first day their dog is scheduled to run. The specific morning start time will be announced online after entries close. Likely it will be at 8AM. During check-in, entry information will be confirmed and exhibitors will receive their souvenir bag including their T-shirt in the size ordered. Supplies are limited and based on what participants requested. Once an exhibitor has checked-in they do not have to check in again at the Secretary Table for this event. However, prior to each run every dog must go through the inspection station.

Fast CAT Invitational - ASSIGNED RUN TIMES & INSPECTION

Dogs will be run alphabetically by breed name and may be alternated by starting with A or Z as the days progress. Exact running order will be announced ahead of time. If temperatures should be unusually warm for this location and time of year, brachycephalic breeds may be run first each morning. AKC reserves the right to change this order and notify entrants. After entries close a list of the running order by breed per day and per track will be available online. The same dog will not exceed more than 2 runs in a given day. Participants are responsible for knowing their breed's run time and to be waiting to run in the queue outside the course after having passed through the roll call / inspection station.

Handlers should report to the roll call station 30 minutes prior to their breed's run time. Not all breeds will run the same days. Owners/Handlers must understand desired run times are not always possible. Please note - dogs must adhere to their assigned run time for their breed during the Final so that Best of Breed can be awarded following each breed's run.

A [text message sign up](#) is now available to participants so they can get the latest news and updates via a text message sent to their phone. Participants are encouraged to sign up for text message alerts to learn when the Fast CAT Invitational webpage, www.akc.org/akcfastcatinvitational has been updated which will show the latest info such as - running order, run times, latest results and report of dogs advancing to the Final, etc.

COMPETITION FORMAT

This event will be held outdoors using a drag lure system with electronic timers on two separate tracks. The lure will be a white plastic bag. Exhibitors are not to bring their own lure and will not be given individual lures. Releasers and catchers will be available to help participants. The next page shows the general scheduling for each day. Each dog will have the potential to run a total of three times for this event. All dogs will run twice as their preliminary runs and if they advance to the Final they will run a third time. All runs during this event will count towards titles.

Scheduling of Days: It is estimated that Friday thru Sunday will be reserved as preliminary days. Across these days, dogs will have an opportunity to run twice, so that 2 run times are recorded. After all preliminary runs are held, dogs advancing to the finals will be determined based on fastest times from either run. Breeds with only 2 or 1 dog entered, will automatically advance to the finals. For breeds that have more than 2 dogs running, only the top 2 fastest dogs will advance. In order to receive a Best of Breed award, all advancing dogs must run in the final. There is no requirement that a dog must run both runs in the preliminary.

After each dog has had the opportunity to run twice, the preliminary portion of this event has concluded and Finals will take place the following day. AKC reserves the right to change the schedule based on entries and weather. Following the last run of the event, a break of approximately 90 minutes will take place to complete final tabulations and to match all placements with awards. Final runs will determine the top 10 placements in two Divisions – 1. Pure Speed 2. Speed of the Breed. The time and location of the awards ceremony will be announced. Winner photos will follow.

HEIGHT CLASSES

The height class used for each dog will be based on the height class provided on the entry. The information provided on an entry form is to be true as understood by the handler or duly authorized agent. AKC reserves the right to change a handicap at any point prior, during or after the Fast CAT Invitational when in the opinion of the Event Committee a handicap appears incorrect. The Inspection Committee or Event Committee reserves the right to measure if the Committee believes it is necessary. The handicap will be used when awarding the top 10 fastest dogs based on pure speed in each of the three height classes: 18" or greater (1.0 handicap for large dogs), 12" up to less than 18" (1.5 handicap for medium dogs), below 12" (2.0 handicap for small dogs).

SCHEDULE AND AWARDS

This is a general and estimated guideline of the scheduling for the event and maybe subject to change depending on number of entries or other factors such as weather. Running order will go according to alphabetical order of breeds. It is possible if it happens to be warmer than expected, brachycephalic breeds will run first.

*Note: There will be (2) Open non-Invitational Fast CATs held concurrently prior to the Invitational on Thursday, September 17. Some entrants may wish to use this day for warm-up. Please see this premium list for all details.

Preliminary Fast CAT Invitational Runs determine dogs that advance to the Final. Top two dogs of each breed advance to the Finals. Final runs determine the top 10 placements in two Divisions.

- **Pure Speed Division** – runs will be tabulated for all breeds according to raw speed in MPH. After all final runs are complete, the top 10 fastest dogs according to MPH will each be awarded a placement rosette. The top 4 placements in each height class will also receive a placement trophy. (30 winners total)
- **Speed of the Breed Division** – runs will be tabulated according to the highest percentage of speed, run above the established average speed of a given breed. After all final runs are complete, dogs with the top 10 highest percentages of speeds ran above their breed's average speed, will each be awarded a placement rosette. The top 4 placements will also receive a placement trophy. (10 winners total)

Best of Breed Rosettes will be awarded to the dog with the fastest time for their breed in the final. (1 winner per breed)

Qualifying Rosettes will be presented upon completion of each preliminary and final run. **Titling Rosettes** will be available to those dogs earning a qualifying run which satisfies the requirement to earn a Fast CAT title. Exhibitors will be asked on their entry form if their dog is expected to title at the Invitational.

CATALOG LISTING

AKC titles and ownership information acknowledged for the purposes of the catalog and recognition of awards shall be from AKC's official records at the time of entry. A digital catalog will be published online on the events main webpage where it will remain for historical purposes.

COURSE EQUIPMENT & CONDITIONS

The Fast CAT courses and setup shall adhere to the AKC Fast CAT Regulations. There will be two courses outdoors on a grassy field and completely fenced with usual temporary fencing. A drag lure system will be used for each course. Lures used will be a white plastic bag. Each dog will be announced and seconds will be displayed at each course. In the event the main timer does not trip, the time recorded from the 2nd backup timer will be used. All recorded times are final. The run out will be 70 yards for each course.

Exhibitors and spectators will be required to leave ample room off the sides of the course and not stand or congregate along the course fencing during official runs. Reminder cones may be visible on the field about 20 ft. off the course side.

The Fast CAT Invitational will be located on the Lower Field of the grounds of the Sycamore Creek Family Ranch. See included Maps provided in this premium list.

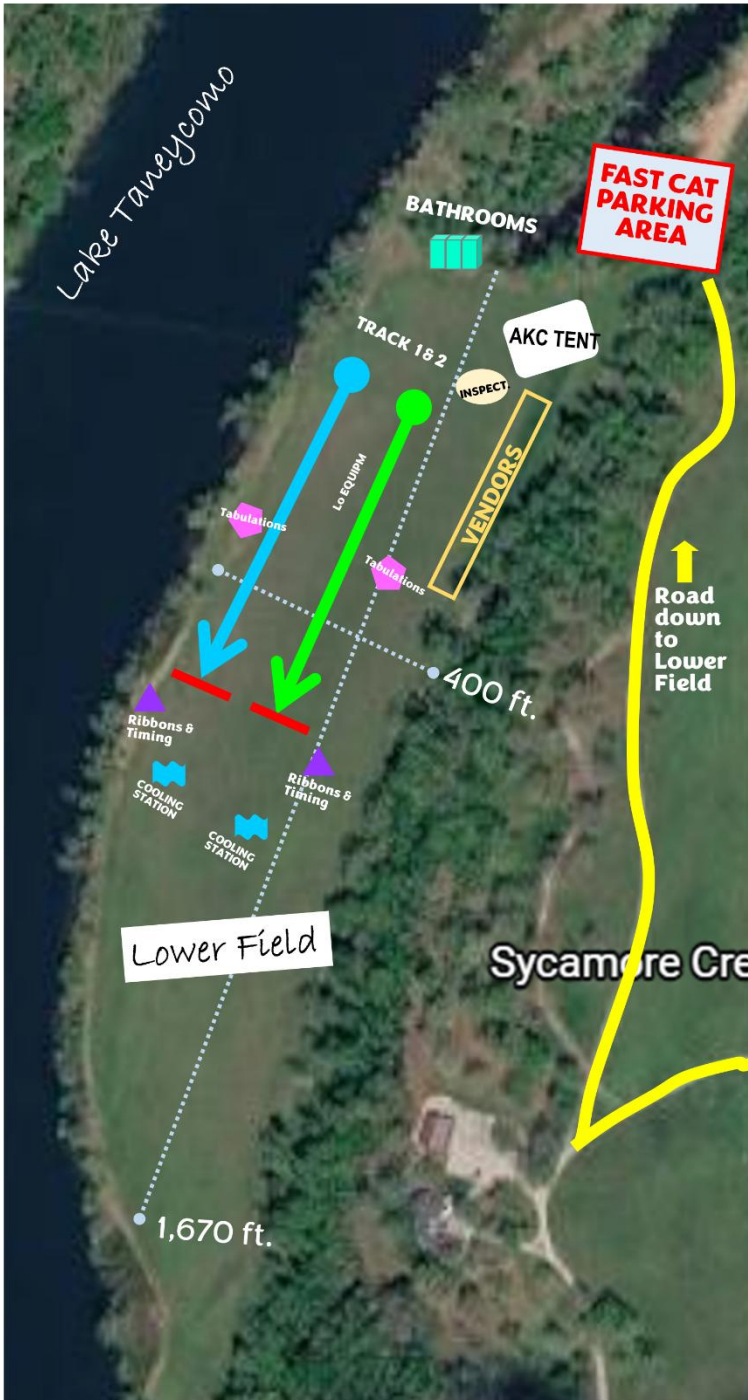

Scale and proportions are approximate.

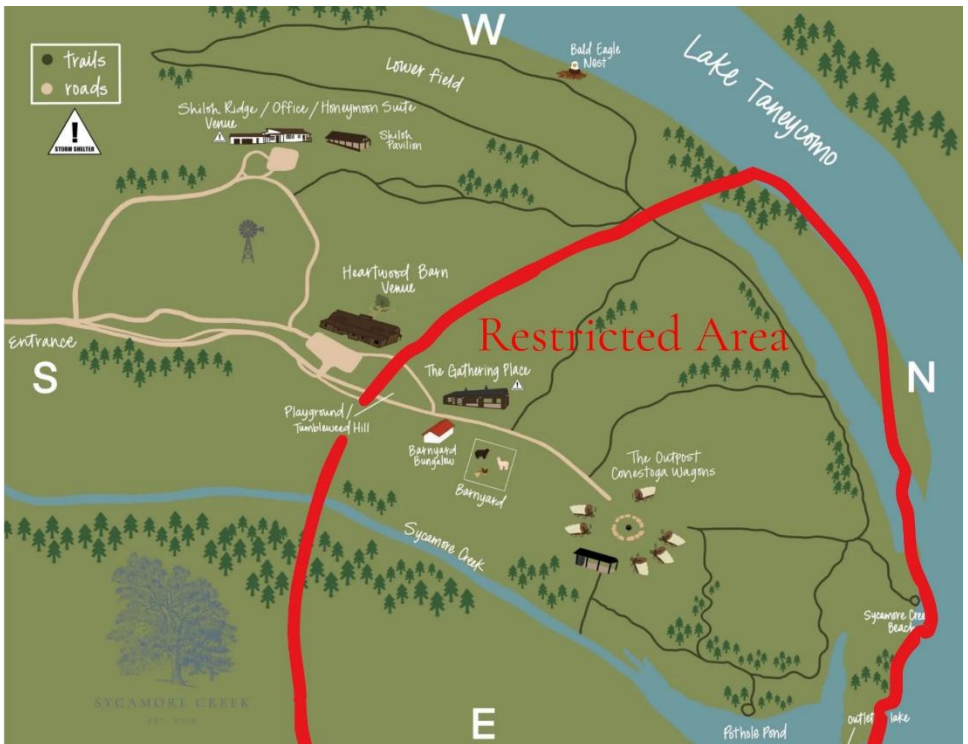
Map #1: Lower Field Detail

PROPERTY RULES - SYCAMORE CREEK FAMILY RANCH

The American Kennel Club and the Sycamore Creek Family Ranch will not be responsible for any lost or damaged items left at the event site. Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. ******Security cameras are in use throughout the property.******

Attendees must show respect in the keeping of the Fast CAT field as well as any other part of private grounds of the Sycamore Creek Family Ranch as they found it and pickup after their dog. Baggies will be provided to all entrants in their souvenir bag and will be available for anyone. If you are in need of a bag please use the one provided or take from the ones at the tent or by the receptacles. Multiple receptacles will be on the grounds to deposit dog waste and bags will be provided at each one. **OWNERS/HANDLERS FOUND NOT PICKING UP AFTER A DOG THEY ARE WALKING WILL BE ASKED TO LEAVE AND MAYBE SUBJECT TO DISCIPLINARY ACTION.**

Rules applying to everyone on the grounds of the Sycamore Creek Family Ranch

- No one may be on the event grounds outside of event hours.
- Smoking and vaping are prohibited anywhere on the property.
- Recreational drugs (legal or illegal) are prohibited anywhere on the property.
- **NO alcohol permitted at the venue:**
- No one may bring their own alcohol onto the property.
- Animals must be leashed or crated, when not actively participating in events.
- Animal waste must be immediately picked up and disposed of properly.
- No relieving of animals in designated non potty areas.
- Vehicles must remain on designated roads and in designated parking areas.
- Vehicles may not be driven across the property to the Heartwood Barn or Sycamore Tree area.
- No chalk, crayons, paint, or paint pens may be used on the property or venue surfaces.
- No pushpins, nails, screws, staples, tacks, glue, adhesive material, or chains may be used anywhere in the Heartwood Barn or Shiloh Ridge event venue, on trees, chairs, benches, and in landscaped areas.
- Guests who endanger others, threaten property, or violate the alcohol policy may be removed from the premises.
- ******Security cameras are in use throughout the property.******
- Abusive, threatening, harassing, hostile, or offensive behavior toward staff, vendors, or others is prohibited. Individuals who continue such behavior may be removed from the property.
- No exhibitors or dogs are allowed inside the Heartwood Barn or Shiloh Ridge buildings – exhibitors may use the bathrooms located off the Heartwood Barn. No dogs allowed in the bathrooms.
- Non-service animals are not permitted inside the Heartwood Barn or Shiloh Ridge venues.
- Glitter, rice, confetti, silk flower petals, Chinese lanterns, sparklers, anything with a live flame are prohibited.
- Smoke effects, explosives, fireworks, and unauthorized pyrotechnics are prohibited.

- Exhibitors must abide by all directions signs on the property and not go into restricted areas.

Rules applying to vendors on the grounds of the Sycamore Creek Family Ranch

- Vendors must conduct themselves professionally and may not engage in abusive, threatening, hostile, offensive, or harassing behavior toward SCFR staff or others. Vendors may be asked to leave if the behavior continues.
- Driving is restricted to designated roads, entrances, exits, and parking areas.
- Vehicles may not be driven across the property to the Heartwood Barn or Sycamore Tree area.
- All vendor vehicles must be removed from the property at the conclusion of the event to avoid towing.
- Music must comply with Branson noise regulations, with particular care taken to be respectful in the mornings.
- Deliveries must occur during the event hours and dates. Materials not picked up on time may incur additional charges.
- Chalk, crayons, paint, and paint pens may not be used.
- No pushpins, nails, screws, staples, tacks, glue, adhesive materials, chains, or Command Strips may be used on buildings, trees, furniture, or landscaping.
- Venue décor owned by SCFR may not be moved or removed.
- Vendors selling goods must utilize the Lower Field unless special permission is given to set up on the Upper Field. All vendors must have signed a contract with the host, AKC.

From the North via US-65: Take US-65 South continue and it becomes US-65 Business, continue and it becomes Veterans Blvd. You will travel in the heart of downtown Branson, go over the bridge, the road becomes Red Rte, then take the roundabout heading left onto State Hwy 76 E stay on that for about 2.5 miles then make a quick left on State Hwy T. State Hwy T will turn into Sunset Inn Rd. Stay on Sunset Inn Rd. and keep going all the way down until you see the iron gates for the Sycamore Creek Family Ranch. Please follow directional signs.

From the South via US-65: Take US-65 North continue and it becomes US-65 Business, then it turns into Lake Rd. Go pass the roundabout staying straight onto Hwy 76 E for about 2.5 miles then make a quick left on State Hwy T. State Hwy T will turn into Sunset Inn Rd. Stay on Sunset Inn Rd. and keep going all the way down until you see the iron gates for the Sycamore Creek Family Ranch. Please follow directional signs.

From the East via State Hwy 76: Head west on State Hwy 76 until you see State Hwy T where you will make a right onto State Hwy T. State Hwy T turns into Sunset Inn Rd. Stay on Sunset Inn Rd. and keep going all the way down until you see the iron gates for the Sycamore Creek Family Ranch. Please follow directional signs.

From the West via State Hwy 76: Head east on State Hwy 76 to US-65 South. Continue and it becomes US-65 Business, continue and it becomes Veterans Blvd. You will travel in the heart of downtown Branson, go over the bridge, the road becomes Red Rte, then take the roundabout heading left onto State Hwy 76 E stay on that for about 2.5 miles then make a quick left on State Hwy T. State Hwy T will turn into Sunset Inn Rd. Stay on Sunset Inn Rd. and keep going all the way down until you see the iron gates for the Sycamore Creek Family Ranch. Please follow directional signs.

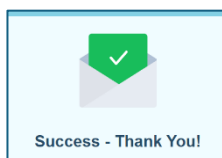

Fast CAT events are open to all dogs at least 12 months of age that are individually registered with the AKC, recorded in the Foundation Stock Service (FSS) program, individually registered with a foreign or domestic registry organization whose pedigrees are acceptable for AKC registration, dogs granted a Purebred Alternative Listing (PAL) number, dogs with AKC Limited or Conditional Registration, or dogs enrolled in the AKC Canine Partners program. Dogs with breed disqualifications and monorchid/cryptorchid dogs are eligible to participate. Females in season and lame dogs may not enter. A dog may enter only once per event. (An event is defined by an event number.) If you have any questions, please contact the event secretary.

NOT REGISTERED WITH AKC: You can register your dog through the AKC Canine Partners program the day of event. Breed will be marked as “All American Dog.” Contact Field Secretary for more details! Qualified runs during this event will be counted toward your title.

ENTRY INFORMATION

These events will be conducted in accordance with the [AKC Fast CAT Regulations](#). The Event Committee shall have the authority to decide upon any matter arising which is not already specifically addressed in the Fast CAT Regulations. Fast CAT Test is a timed straight 100-yard dash for dogs. It is meant to be a fun and healthy activity of interest to any dog owner. Dogs run singularly.

How are Fast CAT Points and Titles Awarded?

The dog's time to complete the 100-yard dash is converted into MPS.

A handicap system is applied to a dog's MPS to determine the number of points earned.

The handicap system is based on the height of the dog at its withers.

18 inches or greater = handicap of 1.0

12 inches to less than 18 inches = handicap of 1.5

Below 12 inches = handicap of 2.0

Points = MPS multiplied by the dog's handicap.

The inspection committee reserves the right to measure if necessary.

Fast CAT titles are suffix titles earned at designated milestones.

BCAT = 150 points

DCAT = 500 points FCAT = 1,000 points

FCAT = every additional 500 points

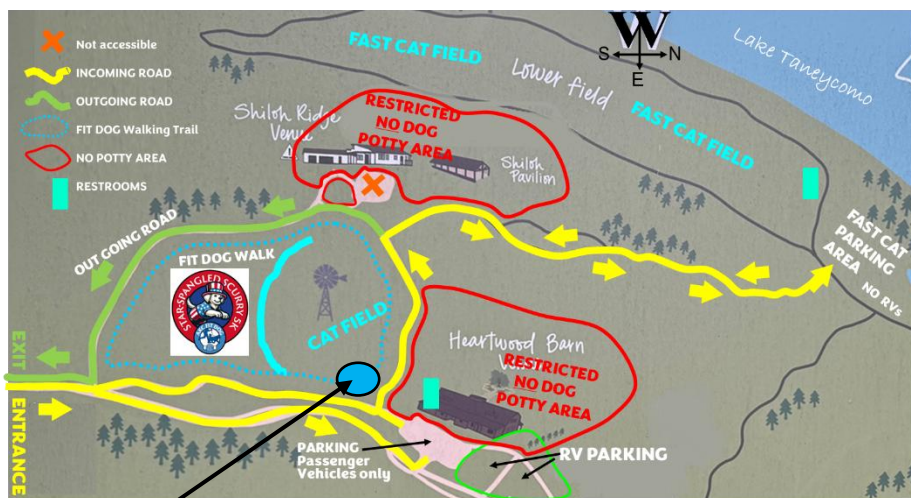

For First Time Coursers & Handlers

★ **WHAT ARE 'DAY OF' ENTRIES?** - Entries accepted after the closing date and up until the day of event are considered Day of Entries.

Please Note: Be aware that there may be a long delay before day of entrants can run, all pre-registered dogs run at a scheduled time slot - unless there is a conflict.

Day Of entries must be done online no paper entries will be processed.

★ **WHAT IS ROLL CALL?** - The time, prior to the commencement of running, by which you are supposed to have your dog ready for inspection by the Inspection Committee. At roll call the dog is examined for lameness or in season. Both spayed and unsplayed bitches are examined to see if they show any evidence of being in season.

★ **WHAT IS AN INSPECTION?** - Dogs will be inspected by a designated inspection committee consisting of at least two people who are members of the hosting Club. The members shall inspect each entered dog for lameness, fitness to compete and female estrus (in season), before each test run. Please Note: Inspection shall take place prior to any form of wrapping being applied to the dog. In the opinion of the Inspection Committee, any entrant found to be lame, unfit to compete or in season shall not be allowed to test and the applicable entry fees shall be refunded.

INSPECTION: Must take place before each test that the dog is entered in. (If you are entered in both tests on one day, then the dog is inspected twice).

★ **WHAT IS A BLOCK SCHEDULE?** - This is a scheduled block of time that is divided into one-hour time blocks with concurrent tests. For example, 9 AM to 10AM, dogs in that group should be at the check in table no earlier than 8:50 AM and no later than 9:30 AM to run in that time block. These events will run CONCURRENTLY using a BLOCK schedule. A time block will be assigned, we will do our best to accommodate requests, but preferred time blocks are not guaranteed. An email explaining the process will be sent out prior to the test.

Early acceptance of dogs for members of the event committee may begin one hour prior to published test hours

TIPS FOR HANDLERS

The field is fenced. However, it is strongly recommended that prior to running your dog, you have good "recall" control over your dog, as the dog will be off leash.

Handlers should wear comfortable shoes and be physically able to hold and release their dogs, as well as catch them.

Dogs will be brought to the start line on leash and released only upon a verbal signal ("Tally-Ho!") from the Hunt Master. Dogs may be released by hand, folded leash or using a traditional lure coursing slip lead. Handler should have someone familiar with the dog at the end of the course to retrieve the dog or have someone else release their dog at the start line. The handler is expected to promptly secure the dog and leave the field with the dog on leash.

WHAT HAPPENS IF IT RAINS? This is a rain or shine event. Please plan accordingly.

GENERAL INFORMATION

ELIGIBILITY

This event is open to all dogs at least one year of age by the day of the event. Dogs must be individually registered with the American Kennel Club, recorded in the FSS program, dogs with PAL numbers, and dogs enrolled in the AKC Canine Partners program are eligible. Dogs with breed disqualifications and monorchid/cryptorchid dogs are eligible to participate. If your mix breed dog needs an AKC Canine Partner number a form and information is available at

Mixed breeds **MUST** be spayed or neutered to be eligible to run. Mixed breed dogs that have been listed with the AKC Canine Partners may participate provided their listing number has been recorded on the entry form. Breeds should be marked as "All American Dog". All American dogs without a Canine Partner number **MAY** register for the AKC Canine Partner program at the field and run for qualifying points.

A dog may enter only one time per test. Each test has an individual event number. There are two test/events each day. Events are run **CONCURRENTLY** - meaning the option to run both events in the same time block is allowed.

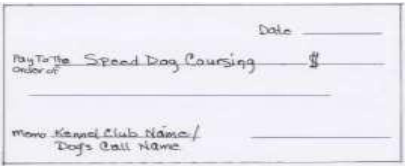

After entering your information, you will receive a confirmation email from Secreterrier. Make sure you check your spam if you can't find the email. If you don't receive an email, you may have typed your email address incorrectly, so you will need to register again. Click the link on the email you received and it should take you back to Secreterrier and tell you your email is now confirmed.

Log in to your account via the top right "User Login" button. Account Information. Click the "Account" button in the top right corner. You should see your account information. Click on the edit icon next to "Account Info" and add your address (you cannot enter events online without an address). Make sure you hit the submit button at the bottom of the page after entering your address so that it saves. To get to the event page, go to “Upcoming” on the top navigation bar. Find your event, and click “details”. This will take you to the About Page.

Go to the Enter Tab. Here you will see all the dogs you have registered. Click on the dogs you want to enter. Select all the buttons that you want to enter, then hit “Get Entry Form”. This will bring a form for you to enter relevant information for all your selections.

Once you have filled out all of your forms for all of the dogs you want in the event. Click “No” when it asks to enter another dog. Changes, additions, or corrections to an entry, entry substitutions, or cancellations must be received by email to the **Event** Secretary prior to the closing date of the test. Other means of notification will not be accepted.

All AKC Rules regarding sportsmanship & conduct apply.

Handler may carry toys or treats on their person to assist with retrieving their dogs at the completion of their run.

ROLL CALL

Roll Call is the time when participants are expected to check in by. Check-in will open 10 mins before each block is scheduled to run. (ie – 10-11AM block will open at 9:50AM). Check-in is followed by inspection for fitness, lameness and “in season” bitches. At inspection, all dogs will be examined for disqualifications. Bitches known to be in season are not to be brought to the test. At inspection, bitches in season, lame and unfit dogs will be excused with entry fee refunded. **DOGS MUST BE INSPECTED BEFORE EACH RUN.**

CAT TEST HOURS: Concurrent tests, start at 10 a.m. until 5 p.m. Friday-Saturday and 10AM until 4PM Sunday. Runs will be divided into one-hour time blocks with concurrent tests. We will do our best to accommodate requests, but preferred time blocks are not guaranteed. If all blocks fill, more time slots may be added to accommodate additional entries. Workers/volunteers may run their dogs prior to the first morning block, or their dogs may be added in during the day. We will do our best to work around conflicts. If you have a conflict, please let the Test Secretary know. Early acceptance of dogs for members of the event committee and workers may begin one hour prior to the published test hours.

WHAT MUST MY DOG DO TO PASS THE C.A.T.? The Coursing Ability Test (C.A.T.) is a pass/fail test. In order to pass, the dog must chase the plastic lure, and complete the course 1 time, by itself, with enthusiasm and without interruption within the maximum amount of time. The judge keeps the official time and decides the merits of the dog's performance. If there is a question which course a dog should run, the judge will decide.

Any dog that eliminates on course will receive a non-qualifying (NQ) score.

DISTANCE AND MAXIMUM TIME. Dogs run singly in Coursing Ability Test events.

Veteran dogs may run two-thirds of the normal distance at the owner's discretion.

Veteran dogs are defined for this test as dogs older than 7 years of age. A veteran dog's owner must declare prior to the start which distance the dog will run.

300 Yard Course. This distance is for dogs shorter than 12 inches at the withers and/or brachycephalic ("flat-faced") dogs. A veteran dog may run 200 yards at the owner's discretion. A dog must complete this course in less than 1 minute. Brachycephalic breeds are determined by the Parent Club.

600 Yard Course. This distance is used for all dogs that do not run the 300-yard course. A veteran dog may run 400 yards at the owner's discretion. A dog must complete this course in less than 2 minutes.

If there is a question whether a dog should run the 300 or 600-yard course, the judge will decide. The premium shall state the distance for each course and the eligibility of dogs for each course, including that veteran dogs may run two-thirds of the normal course distance at the owner's discretion.

CAN MY DOG EARN AN AKC TITLE FOR COURSING ABILITY?

Titles will be awarded for dogs that pass the coursing Ability test the required number of times. These are suffix titles that will appear on a dog's pedigree with a higher-level title superseding a lower level title. Coursing Ability (CA) -Awarded to a dog that passes the Coursing Ability Test 3 times under at least 2 different judges. It is the HANDLERS responsibility to ensure they have a different judge for at least 1 of their runs!

Coursing Ability Advanced (CAA) - Dog passes the Coursing Ability Test 10 times. The 3 previous runs count towards this title. So, the dog needs an additional 7 runs.

Coursing Ability Excellent (CAX)- Dog passes the Coursing Ability Test 25 times. The 10 previous runs count towards this title. So, the dog needs an additional 15 runs.

CAX Numeric Title: CAX 2,3,4, etc. For every 25 qualifying runs the dog earns another CAX title.

AWARDS

Rosettes for completing titles CA, CAA, CAX, CAX+, as available. Please notify Speed Dog in advance if you are anticipating a new title. Notification must be in writing via paper entry or online entry form.

SPECIAL/FUN AWARDS WILL BE GIVEN OUT EACH DAY! EXAMPLES:

Oldest Team (combined ages of handler and dog), Youngest Team (Combined ages of handler and dog), Most "creative" course (Judge to decide), Cheater, Cheater, Bunny Eater (Judge and Huntmaster to decide). Exact special / fun awards for this event to be determined and announced.

NOTICE TO EXHIBITORS

- These CAT events will be run and held in accordance with AKC Regulations and Policies. ALL DOGS RUN AT OWNER'S SOLE RISK.
- All AKC rules regarding sportsmanship and conduct apply.
- A gas, electric or battery operated continuous loop lure machine will be used. Backup equipment will be available. The lure will consist of plastic bags.

- An electronic break-the-beam timer will be used to record time. Dogs will be running on a natural grass surface.
- On site bathrooms will be available off the Heartwood Barn.
- The course will be fenced with temporary mesh fencing.
- The Huntmaster is responsible for field safety and therefore he/she is in complete charge of all dogs and handlers on the field. The Huntmaster has the authority to stop the lure in any potentially dangerous situation and signal the handler to retrieve the dog on the course.
- Running your dog will be brought to the start line on leash and released only upon a verbal signal "T" tally ho" from the Hunt master. It is recommended that dogs be handled with a "slip lead" that gives instantaneous freedom to the dog when "T" in tally ho" (release) sign is called by the Hunt master. Dogs may be released by hand, folded leash or using a traditional lure coursing slip lead.
- Coursing is an athletic activity that can tax a dog's physic endurance. Dogs that are out of shape and/or overweight may be at greater risk of injury or exhaustion. The inspection committee has the authority to disallow a dog's entry into a test, and in such instances, applicable entry fees will be refunded, service fee's will not be refunded.
- **The Test Committee, will make and enforce any rules they deem necessary to ensure the continuity of the Tests and the goodwill of the landowner.**
- No entries will be accepted by phone or fax.
- Changes, additions, or corrections to entry forms must be received in writing prior to the close of entries. Those received by telephone are not acceptable. Please notify the Secretary of any change of address.
- No entry shall be made, and no entry shall be accepted which specifies any condition as to its acceptance.
- Returned/Re-deposited/Post-dated checks do not constitute a valid entry.
- Waiver of Rights - The club reserves the right to remove any animal in distress from a parked vehicle or crate, and all persons attending these dog events hereby waive any claim for damages against the clubs for such removal. PLEASE NOTE: It is expressly understood that exhibitors or spectators alone are responsible for the behavior of their dogs and/or children. Any exhibitor or spectator whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior or whose equipment creates an impediment to the safe flow of traffic may, at the discretion of the Event Committee, be asked to leave the event site. In such cases, no refund of any fees paid will be made.
- The American Kennel Club, Speed Dog Coursing, Event Secretary, their agents, employees, volunteers assume no responsibility for any loss, damage, or injury sustained by exhibitors, handlers, or any of their dogs or property and further assume no responsibility for injury to children & further expect exhibitors and spectators to keep their children and dogs under strict control of their dogs or property and further assumes no responsibility for injury to children or spectators before during or after this event.
- All AKC Rules and Regulations will be enforced by the Event Committee under AKC guidelines. Failure to comply with these rules will result in charges being brought

before the Event Committee.

- Any event hearing, disciplinary action, rule violations, complaints, or charges will be handled in accordance with the AKC Dealing with Misconduct booklet.
- No dogs allowed in rest rooms, and no washing of animal food containers in rest rooms.
- No entering restricted areas on the grounds and no relieving dogs in restricted areas.
- No videotaping or photography during the events for resale is permitted without the approval of the Host Club and the Official CAT Photographer.
- No baby strollers are allowed near the course during test hours.
- All dogs must be kept on leash except when actually competing inside the course.

AKC reserves the right to change daily event scheduling, cancel or reschedule any events during Fast CAT Invitational week should circumstances arise.

EQUIPMENT AND CREW

LURE EQUIPMENT: The CABT field is run with a gas machine (Bobinator) or a battery powered machine (Injoy)

TIMING DEVICES: Speed Dog uses and endorses Farm Tek electronic timing devices.

FIELD CONDITIONS: The field is fairly level. The surface is grass that is mowed short. The track is 600 yards from start to finish. Mounted entry and exit gates are also part of the track. The field is fully fenced with mesh fencing.

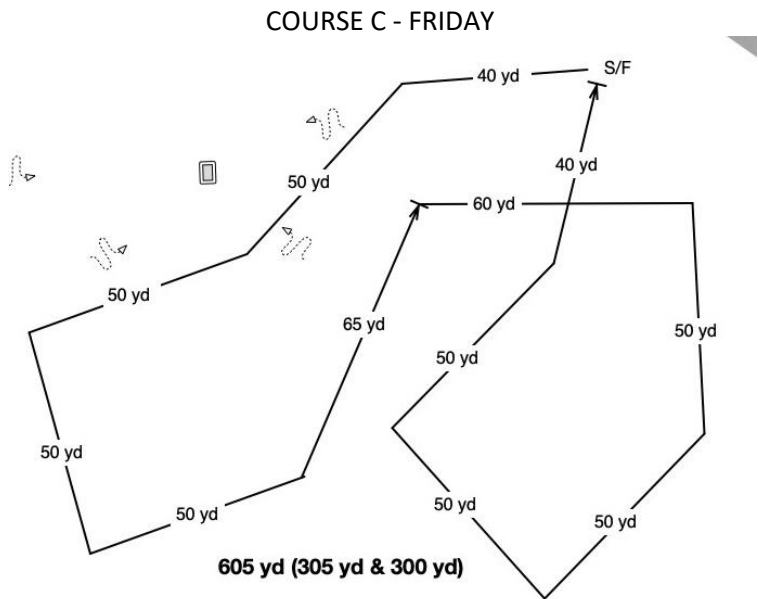
HUNT MASTERS: The Hunt Masters are not just someone standing at the start line twirling their arm. They are an integral part of the overall safety of the dog and human. They are in complete charge of all hounds and handlers on the field. They are responsible for calling the next dog/handler onto the course. They are responsible for making sure the correct dog is on the start line. They are responsible for checking collars. The Hunt Master explains the release and, if necessary, the retrieval before the dog is released. They are responsible for making sure the lure is in position and traveling in the correct direction before calling the dog/handler onto the course. The handler should communicate to the Hunt Master any special needs the dog may have fast, slow, old, new, etc). The Hunt Master will communicate any needs to the Lure Operator. The Hunt Master shall question the Lure Operator, Timer and Handlers asking "Are you ready?" After affirmative answers from all parties, the Hunt Masters will begin the course. They provide a hand signal to the Lure Operator to start the lure. They give the verbal signal "Tallyho" to release the dog from a standing start. The

dog should not be slipped before the sound of the "T" in "Tallyho". The Hunt Master will notify the Lure Operator, Timer and Handler of any issue with the release or the course that results in a rerun or non-qualifying score. The Hunt Master shall stop the lure in the event of a safety issue with the course or the dog.

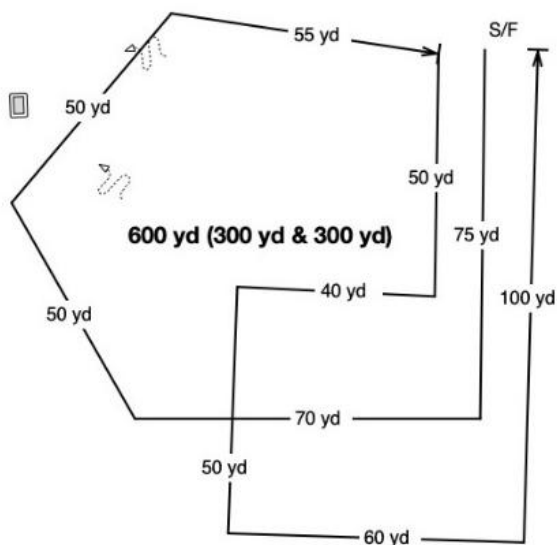
LURE OPERATOR: The Lure Operators are responsible for communicating to the Event Chair, any concerns regarding the track layout. They are responsible for operating the lure in a safe manner for all breeds. The Lure Operator will make a test run beforehand. The Lure Operator will receive communication from the Hunt Master regarding any special needs a particular dog may have (fast, slow, old new, etc). The Lure Operators will do all they can to ensure the safety of your dog. The Lure Operator will not move the lure at the end until the dog is leashed and off the course. For the utmost safety, the Lure Operator will position themselves so that they have a view of the entire course and will watch the dog the entire way until the dog is leashed and off the course. The Lure Operator will stop the lure on a signal from the Hunt Master, but shall automatically stop the lure any time a dog becomes entangled in the string or when a potentially dangerous situation may develop.

COURSE LAYOUT/DESIGN:

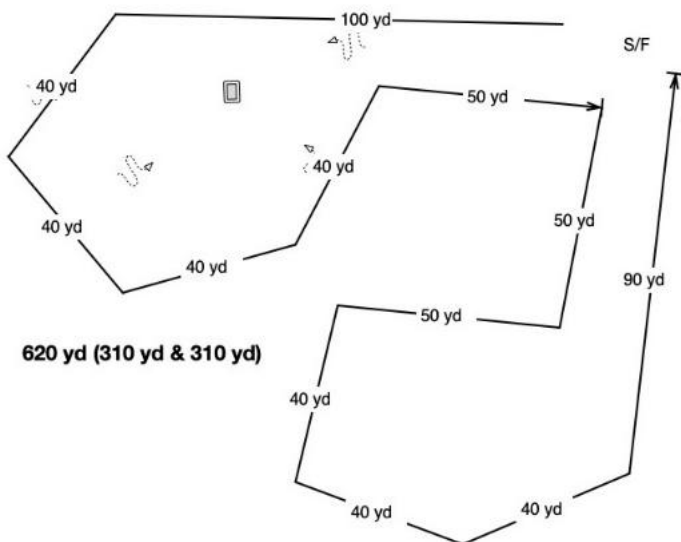
