Breeder Expertise, Thoughtful Analysis Demonstrate Dangerous Flaws In 'Feel Good' Dog Law

U.S. Senator Richard Durbin introduced the “Puppy Protection Act” (S. 4757), a companion to U.S. House Bill 4552—measures that the AKC has expressed concerns about.

The proposal establishes federal mandates for animal care for pet breeders subject to USDA licensing and inspections. While many people think of this as the realm “commercial breeders”, it also impacts small specialty and hobby breeders.

New in the Legislative Action Center: Dogs in Vehicles Policy Resources

More and more Americans are traveling with their dogs. While by and large this is a great thing, it has raised concerns when dogs are left in vehicles when their health and safety could be at risk.

To address this concern, legislation has been proposed in multiple states over the past few years that allow private citizens to remove animals from vehicles if they believe the animal is in danger. These are commonly known as "Good Samaritan Laws".

The Patriotic Puppy Program is a pilot program designed to study how American breeders can provide a suitable and reliable source of future explosives detection dogs for advanced training and deployment by law enforcement or government agencies.

Legislative Information and Updates

Eleven states are currently in session or special session, and several additional states are expected to hold special sessions and/or interim committee hearings over the next couple of months. The U.S. House and Senate are in recess until after the election. To date, AKC Government Relations has tracked more than 3,300 bills at the federal, state, and local levels. The COVID-19 outbreak and response has had a dramatic impact on legislatures and policymaking at all levels of government. Below are some highlights of pending canine legislation issues across the country:

In addition to tracking and responding to legislative proposals, AKC Government Relations addresses dog-related regulatory proposals from the U.S. federal government, all 50 states, and the District of Columbia. AKC Government Relations is currently tracking approximately 750 regulatory proposals, the majority of which concern land use/hunting regulations and those governing the practice of veterinary medicine.
