## PROCEDURE FOR THE FORMULATION AND SUBMISSION OF JUDGING PANELS

- After consulting the AKC's *Judges Directory*, draw up a proposed list of judges making certain that no judge is scheduled to judge more than 175 entries (*Rules Applying to Dog Shows*, Chapter 7, Section 13). Remember that Obedience classes count in a judge's total. The AKC suggests that you work together with the Superintendent or Show Secretary toward the objective of assigning approximately 125 entries, but no more than 150 entries, to at least two of the Group Judges. Take great care in estimating the number of entries a judge's assignment will entail so that the problems resulting from overloads after entries close can be minimized.
- If a Specialty is held as part of an All-Breed show, a judge may be assigned a maximum of 200 entries if the judge is not assigned any other Breed, a Group or Best in Show.
- If the entry for any Obedience judge exceeds the Obedience limits, see the *Obedience Regulations*, Chapter 1, Sections 26 through 29 for the explanation of entry reassignment.
- Write to judges setting forth the judge's entire assignment. **REMEMBER** that **contracts must be breed specific.** To assist with contract preparation, a reproducible checklist of AKC Recognized Breeds is included as part of this Judges Panel form.
- **Before submitting this form, you must have in your possession a letter or breed specific contract from each judge listed herein that expressly accepts the entire assignment listed for that judge on this form** (*Rules Applying to Dog Shows*, Chapter 4, Section 1). The AKC reserves the right to request the acceptance letter of any or all judges on this panel.
- With the exception of visiting judges, **all judges must be eligible for the entire assignment listed in the proposed panel on the date the panel is submitted to AKC. Judges who are in the process of being considered for additional breeds by the Board of Directors may not be assigned a breed(s) for which they are applying.**
- This form may be submitted at any time to the American Kennel Club, Event Operations Dept. PO Box 900051 Raleigh, NC 27675-9051, fax number 919-816-4220. Attention: Event Operations Department, **but no later than 18 weeks before the closing date of entries for the show** (*Rules Applying to Dog Shows*, Chapter 4, Section 1). You may also scan the form to a PDF file or image file and attach the file to an email and send it to [eventplans@akc.org](mailto:eventplans@akc.org).
- Clubs offering the AKC National Owner-Handled Series (NOHS) must submit their NOHS Group and NOHS Best in Show judges at the same time as their regular judges panel.
- Rally events require their own application and judges panel. The Rally application and judges panel can be found at <http://images.akc.org/pdf/events/AEVT02.pdf>.

The Miscellaneous Class must be assigned to an AKC All-Breed judge or a judge eligible for a Group.

Event Committees should carefully examine the estimated number of dogs that may be entered under each judge. In order to prevent possible overloads, clubs may find it helpful first to calculate the approximate number of dogs a judge may expect to draw. This figure can be determined by adding the entry in the breeds assigned to the judge at the previous show(s), plus an additional 10%, to keep the entry within that limit.
