Year in Review: 2020 Was Record Legislative Year for AKC Government Relations

AKC Government Relations had another record year in 2020, with the team tracking some 4,211 bills in 2020. This is an 83% increase over the 2,300 bills tracked in 2019.

The largest category of new bills tracked (716 total) were related to COVID-19, many of which had the potential to impact dog owners and ownership, dog services (such as pet food retailers or groomers) and AKC sports.

Legislative Information and Updates

The U.S. Senate and House of Representatives are back in session and will return to organizing for the new Congress after Wednesday's inauguration. Forty-three states are also in session currently or in special session this month.

Listed below are some highlights of pending legislation impacting dog ownership and dog owners' rights across the country. For more information on these bills, and information on how you can get involved, visit the AKC GR Legislative Action Center at www.akcgr.org.

In addition to tracking and responding to legislative proposals, AKC Government Relations addresses dog-related regulatory proposals from the U.S. federal government, all 50 states, and the District of Columbia. AKC Government Relations) is currently tracking approximately 750 regulatory proposals carried over from 2020, the majority of which concern land use/hunting regulations and those governing the practice of veterinary medicine. 
