PREMIUM LISTS AND CLOSING OF ENTRIES
 (To be read at the December 2, 2020 Delegates Meeting)

| <p><u>CHAPTER 6</u></p> <p>SECTION 2. The premium list shall contain the following: a list of the officers of the show-giving club with the address of the secretary; a list of the members of the Event Committee (there must be at least five) together with the designation of “Chairman” and the Chairman’s address (and “Obedience Trial Chairman” if an obedience trial is being held by a club in connection with its dog show); the names of the veterinarians (or name of local Veterinary Association) and, for an unbenched show, whether the veterinarian will be in attendance throughout the show hours or “on call,” the names and addresses of the judges, together with their assignments, and the name and address of the superintendent or show secretary who has been approved by The American Kennel Club. The premium list shall also specify whether the show is benched or unbenched, and shall give the exact location of the show, the date or dates on which it is to be held, and the times of opening and closing of the show.</p> <p>Notification must be printed in the Premium List only if the club is not offering the three-point major to the Reserve Winners at the National Specialty</p> | <p><u>CHAPTER 6</u></p> <p>SECTION 2. The premium list shall contain the following:</p> <ul style="list-style-type: none"> ● <u>a list of the officers of the show-giving club <u>and the club address</u></u> ● <u>a list of the members of the Event Committee (there must be at least five) together with the designation of “<u>Chair</u>” and the <u>Chair’s</u> address (and “Obedience Trial <u>Chair</u>” if an obedience trial is being held by a club in connection with its dog show)</u> ● <u>the name(s) of the veterinarian(s) or name of local Veterinary <u>Clinic</u> and whether the veterinarian(s) will be in attendance throughout the show hours or “on call,”</u> ● <u>the names, <u>city and state</u> of the judges, together with their assignments</u> ● <u>the name and address of the superintendent or show secretary who has been approved by The American Kennel Club</u> ● <u>Entry fee(s)</u> ● <u>whether the show is benched or unbenched</u> ● <u>the exact location of the show</u> ● <u>the date or dates on which it is to be held</u> ● <u>the times of opening and closing of the show</u> <p>Notification must be printed in the Premium List only if the club is not offering the three-point major to the Reserve Winners at the National Specialty</p> | <p>This amendment was proposed by the Delegate Dog Show Rules Committee.</p> <p><i>Reformats the section to bullets for easier reading and comprehension.</i></p> <p><i>Modifies required components of premium lists by replacing the publication of Secretary’s address with the publication of the club address, replacing the requirement to publish the judge’s address with the judge’s city and state, and adding the requirement to publish the entry fee(s).</i></p> <p><i>Replaces “Chairman” with “Chair” making gender neutral. Replaces Veterinary Association with Veterinary Clinic for consistency and minor housekeeping.</i></p> |
