Seminar Curriculum: The seminar will be split between classroom instruction/discussion and hands-on activities.

Discussion Topics:

Scent Theory
General expectations of judges
Picking and planning search areas
General hide placement considerations. Searches by class level- hide placement, test challenges, judging the search.

Hands-On Learning:

Participants acting as the Judge and Stewards will break into groups to design searches for preselected classes and difficulty levels. After the Demo Dog has run the search the instructor will discuss the search design, hide placement with the group. The presenter will provide their evaluation.

Attendees are not to bring dogs to the seminar.
